Field descriptions		
Name of field	Required/optional	Explanation
First name	Required	Type your first name as you are registered to vote.
Last name	Required	Type your last name as you are registered to vote.
Birthdate	Required	Enter your date of birth.
Residential address	Required	Type your residential address (where you live). This address should be the same as your current registered address.
City	Required	Type the city for your residential address.
Zip	Required	Type the zip code for your residential address.
Ballot name	Required	Type in the exact name you want printed on the ballot.
Mailing address	Optional	If this field is left blank your registered voter address will be posted online.
Mailing city	Optional	Only complete this field if providing a mailing address.
Mailing zip	Optional	Only complete this field if providing a mailing address.
Telephone number	Required	A telephone number is required so that our office can contact you with any questions. This will not be posted online.
Confirmation email	Required	A confirmation email address is required so that our office can contact you with any questions. This email address is also used to provide you with a confirmation of your filing. This will not be posted online.

**3** Select your party + precinct
