## King County Democratic Central Committee February 24, 2010 Meeting Minutes

7:00 CALL TO ORDER

7:01 FLAG SALUTE

7:03 APPROVAL OF AGENDA: Moved, seconded, and passed unanimously

Chair: Remember to thank legislators and governor for hard work, especially for their support of Boeing and for their efforts on suspending I-960. We need to emphasize PCO recruitment. Eastside is doing well - Need to emphasize the 47<sup>th</sup> because of an upcoming State Senate race with a new young Republican challenger to incumbent Claudia Kauffman. All debts for the year have been paid. KC convention is to be run by declared candidates -- because they work for you! It is open to all registered voters who sign in as Democrats. \$30 is the fee for the convention, and will cover the cost of a box lunch. KCDCC Endorsements meeting is scheduled for June 5-6 at the Carpenters Hall, followed by the annual picnic on the 6<sup>th</sup>.

7:10 PROGRAM: West Seattle Democratic Women's Skit on "Corporate Personhood." The skit originated in committee to educate people on corporate personhood. Some highlights: Corporations don't go to work, run for office, have lunch, drink, go on vacation, get sick, have families, have a voice, but can be emailed at customer service. If you want to hear a corporation, look at a paper, congressional budget, health care proposal, etc. We need to campaign to take back America.

7:15 West Seattle Democratic Women Chair Karen Chilcutt presented a \$100 check to KCDCC for 2010 Sponsorship.

7:15 Black History Month: Jackie Roosevelt Robinson was highlighted. April 15, 1947 was tax day and also the day that the color barrier was broken in Major League Baseball. He had been a three-sport star at UCLA and served in the military before signing with the Brooklyn Dodgers. He had a great personality, took abuse, and persevered. 'had a .311 batter average and was Rookie of the Year in 1947. He played in six World Series and was MVP in 1949. He was in six consecutive all-star games and had his uniform number retired across all of Major League Baseball. Off the field, he was active in the civil rights movement and helped market the coffee, "Chock Full of Nuts."

7:18 Special award presented to Dale and Kathy Bright, accepted by Dale, for their terrific support of KCDCC with the annual Honors Banquet and The Evening with King County Democrats in January. They will represent the organization at Congressman McDermott's Potato Feed on March 21<sup>st</sup>.

7:20 Marcee Stone was introduced as a 34<sup>th</sup> District candidate for the State legislature. She was the former Board President for Washington Public Campaigns. She talked about Citizens United versus the FEC. She made a campaign pledge to include a code of ethics, specifically not taking PAC or corporate dollars. She wants her campaign funded by individuals. She loves her district, believes in her vision, and has a website: [www.marceefor34th.com](http://www.marceefor34th.com).

Steve Rosen was introduced and is running for Municipal Court Position Number 3, City of Seattle.

7:25 OFFICER REPORTS: Chair - Plans are in work for a second annual judicial forum in May. Third Vice Chair of Finance, Rosemary Blackwell resigned position due to bad health and work overload; Treasurer Andrew Peabody resigned due to study for Public Administration Masters and new position on local campaign. Chuck Laney is acting treasurer and may be elected next month. Thanks to Rosemary and Andrew for their service to the Party. Also, census is about to kick-off on March 4th, and will bring about many boundary changes in legislative and congressional districts. Washington has grown, may get a 10<sup>th</sup> congressional district. Precinct caucus locations are set. Google doc to that end is available online at the KCDCC website.

7:30 First Vice Chair Chad Lupkes enjoyed running the meeting last month: "It was a hoot." He is updating website, and there is a new navigation bar for Elections. Everyone is invited to precinct caucuses. They will be a grassroots effort, contrary to GOP claims that it is not. There is also a new Standing Rules link on the website.

7:32 Second Vice Chair Joel Ware recommends a "do pass" to the resolution, "Opposition to Demolition of Homeless Encampment." Resolution debated. Sponsor Judy Gibbs spoke pro: We should leave the homeless people and families alone. Many work, and cannot take possessions with them. Steve Zemke offered a friendly amendment to have resolution sent to all King County legislators. The amendment was accepted. The resolution passed unanimously.

February 24, 2010 Meeting Minutes (continued)

7:36 Fourth Vice Chair Emily Willoughby related that the February 9<sup>th</sup> special election was certified this morning. There were no discrepancies. Only two drop boxes were available due to budget cuts. There is a proposal to save money by removing the signature flap. Will Affleck-Ash: Isn't a stamp on an envelope a poll tax? Emily: Direct that question to elections. Also, she adds that we need observers. Sarajane Siegfried would like more drop boxes.

7:45 LAC Co-Chairs Steve Zemke and Sarajane Siegfried reported on lobby day. 85-90 people attended. Governor and legislators spoke. Public campaign bill is still alive. Homebuilder revitalization act and Medicare bill are no-go's. Suspension of I-960 is signed for two years. Tim Eyman is responding with I-1053, allowing a 1/3 minority to kill a tax. Housing trust fund needs support and needs to be listed as a jobs bill. Disability lifeline bill has LAC support.

7:50 Karl deJong (Endorsements) People are jazzed about elections. Mike Finkle was appointed to new district court opening by the King County Council. If people are aware of candidates or aspirants, please direct them to take the KCDCC questionnaire and the new Elections website offering. He sent letter to all LD Chairs asking for appointment of Endorsement Committee members.

7:52 DISTRICT REPORTS: Tim Nuse reported that the 34<sup>th</sup> had a great meeting in [February](#); focus was on jobs now. [R1](#)

Brendan Patrick reports that the 37<sup>th</sup> is having a contested Senate race – State Senator Adam Klein has drawn and opponent.

The 5<sup>th</sup> District report included news of the nomination of Greg Hoover and Dean Willard for the legislature.

Gary Sells reported that, in the 39<sup>th</sup>, there are islands of blue in a sea of red. Mardi Gras fundraiser was a great success. New candidate in the 39<sup>th</sup> to run against the GOP caucus chair is Eleanor Walters for the Democrats.

Martin Chaney reports that the 45<sup>th</sup> had great turnout for the lobby day. They are planning for caucuses and are having a membership drive.

Marie Brooks reported that the Chair of the 41<sup>st</sup> resigned, and she is acting chair is 1<sup>st</sup> Vice Chair. They are working on scheduling caucuses. They thank Chad Lupkes for help with rules. They have had two town hall meetings including 400 people, and several new PCOs. Marie will not seek the chairmanship, and there will be an election for a successor for Chair at their March meeting.

Michael Maddux reported for the 43<sup>rd</sup> LD that they had a good month, including a State of the Union watch party that went over the fire code at a restaurant/bar in Wallingford. He believes turnout in the 43<sup>rd</sup> will influence all state-wide elections in November as the 43<sup>rd</sup> is the most Democratic district, and so turnout will be key.

Chad Lupkes reports for the 46<sup>th</sup> that they have been very active and rules-conscious. They are "rockin' and rollin'."

8:05 BREAK: Ivan Weiss, former head of Vashon Island's farmer market had his farm-fresh eggs to offer. Also, O! Sodas were offered and sold by Larry Grubb of the 11<sup>th</sup>.

8:10 NEW BUSINESS: Auction for hot steaming sweet potato pies. Karl deJong started bidding at \$5. Sabra Schneider won the pie for \$15. Two tickets for the theatre production, "Legally Blonde" were also auctioned, with Ian Jacobson starting bidding at \$20. Brendan Patrick won them for \$30.

8:15 Steve Zemke notes that there are limited number of places to vote at the King County Conservation District Election. It is often swayed by conservatives, but a progressive turnout could easily swing the vote.

8:18 OLD BUSINESS Bylaws: The leadership council unanimously recommended approval of the proposed bylaws as posted at the website and copies provided this evening. Friendly amendment offered and accepted for "or designee or first vice chair" to be inserted after the word "chair" in Section 5.4, "Duties of Chair." Will Affleck-Asch recommended deletion of the number 1 under Article XI, line 4, after the words "members shall be notified." Steve Zemke recommended the addition of additional individuals in the last sentence of article one to make it parallel to other sections.

February 24, 2010 Meeting Minutes (continued)

8:22 Call the question (no second or vote on the motion.) The main motion, passage of the bylaws, was passed unanimously. Suzie indicated she would incorporate suggestions as friendly amendments and post approved bylaws at the website and provide file copy for the office.

8:24 GOOD OF THE ORDER

Tracking bills from labor and commerce committee. Also the jobs bill (2561), known as the jobs act of 2010.

Suzie: I-1068 -- The marijuana bill will likely receive early consideration (Will Affleck-Ash knows it will save the state money.) I-1053 and I-1066 will receive "No" and "Decline to sign" recommendations.

Steve Zemke: Some changes to initiative process are in the form of a bill -- the changes will affect signature gathering. David McDonald is to be involved with voter registration forms to accommodate felons who may now legally vote.

Ivan Weiss: There are one dozen eggs left!

Karl deJong: A labor caucus has started in the 34<sup>th</sup>.

Other: Public option received grassroots support for reconciliation.

Steve Rosen, candidate introduced earlier, addressed the group and explained that he is a Black Diamond municipal judge currently (seeking appointment to Seattle Municipal Court) and is endorsed by 38 sitting judges.
